### SUMMARIZE

**ARTICLE 1.-** All kind of complaints about hidden defects will be attended in accordance with Real Decreto Legislativo (Royal Legislative Decree) 1/2007 of 16 November, approving the revised text of the Ley General para la Defensa de los Consumidores y Usuarios (General Law for the Protection of Consumers and Users) and other approved complementary laws (hereinafter RDL 1/2007).

Lamps and light fittings are subject to the warranty period established in RDL 1/2007, all products have a 2 year manufacturer's warranty from delivery date of the product unless a longer period of time is established.

**ARTICLE 2.** - Responsibility for SECOM ILUMINACION, S.L. is limited to the delivery of the components that have suffered a malfunction (PCB Led, driver, etc.), not being extensible to other expenses that may result from the replacement of components that have suffered a malfunction, such as transport costs, accommodation, travel, cost of the labor hours, freight elevators, trucks, cranes, machinery, daily subsistence allowances, etc., or any other direct or indirect damage or injury such as loss of profits.

**ARTICLE 3.** - SECOM ILUMINACIÓN S.L. is responsible for the quality of its light fittings as long as the above recommendations are followed and the company renounces all liability for:

- Non-compliance with the installation instructions or maintenance.
- Improper storage or installation.
- Incorrect use.
- Change of products after the sale.
- Incorrect Power Supply.
- Affections by the use of non-indicated cleaning products.
- Logical deterioration by the passage of time, cuts, scratches or damage caused by impacts or accidents.
- External Agents.

### CONTRACT CLAUSES

**SECOM ILUMINACIÓN S.L.** is committed to the implementation of this guarantee extension certificate, for a period of **2 years**:

- 1 - The warranty shall run from the date of delivery of the product to the customer.
- 2 - The assumption that the customer prefers that the components that have suffered malfunctions are repaired by SECOM LIGHTING, S.L. luminaires must send through freight paid. SECOM LIGHTING, S.L. proceed to the replacement of components as soon as possible and send the light fittings in perfect operation through customer freight collect.
- 3 - Maintenance, cleaning and as part of its normal use wear and tear, as appropriate, are not met by the terms of this guarantee.
- 4 - Commercial invoice and where appropriate, delivery documents, that individualize the product and the delivery date, are attached with the present document, and they should be displayed together with this warranty to enforce it.
